

1. OUR COMMITMENT TO YOUR PRIVACY

This notice describes our Privacy Policy. Our privacy policy is designed to advise you about how we collect, use, and protect the personal information you provide. By visiting this site, you are accepting the practices described in this privacy policy.

Your privacy is very important to us. We have created this privacy policy to show our commitment to the protection and interest of your information that is collected.

To better protect your privacy we provide this notice explaining our online information practices and the choices you can make about the way your information is collected and used.

2. WHAT INFORMATION IS COLLECTED

- (a) **Information You Provide to Us:** We collect any information you enter on our site or that you give us in any other way. You can choose not to provide certain information, but you may not be able to take advantage of our services and features.

3. HOW AND WHEN THE INFORMATION IS USED:

The information we collect is used for administering our business activities. Occasionally, we may use the information to notify you about changes to our website, new services, or special offers.

We may disclose your personal information to third parties who work on behalf of us to provide products and services requested by you. We will share personal information for these purposes only with third parties whose privacy policies are consistent with ours or who agree to abide by our policies with respect to personal information.

We may otherwise disclose your personal information when:

- (a) We have your expressed consent to share the information for a specified purpose
- (b) We need to respond to subpoenas, court orders or such other legal process
- (c) We need to protect the personal safety of the users of our websites or defend our rights or property

We use non-identifying and aggregate information to better design our website and to share with our marketing department.

Finally, we never use or share the personally identifiable information provided to us online in ways unrelated to the ones described above without also providing you an opportunity to opt-out or otherwise prohibit such unrelated uses.

4. HOW WE PROTECT YOUR INFORMATION:

Your access to some services and content is password protected. We advise that you do not disclose your password to anyone. In addition, we recommend you sign out of password-protected services at the end of your session.

6. WHO HAS ACCESS TO THE INFORMATION:
